Foreword by Association President

Lt Gen Richard Nugee CB CVO CBE

2025 appears to have been the year of published strategies – Defence Review, Industrial Strategy, Defence Industrial Strategy to name a few – and a reaction to the US questioning how much Europe is paying for its Defence. As a result we have a commitment from the Government for more Defence spending, although it will not satisfy those who think we should be doing more, faster. But the trajectory is up, for the first time in ages, and this can only be a good thing for the Army. The Artillery are also increasingly being recognised (again!) as an essential part of any ORBAT – the very poor state of field artillery (14 x 155mm guns in the whole Army) is being addressed, and we established the King's Gurkha Artillery, which is a triumph of a change and I am sure they will be made hugely welcome.

The mood appears to be upbeat – with the largest ever Defence Sales Exhibition in September – although the scale of what needs to be done to prepare for the potential for more tension in Europe is not being underestimated. With Russia testing Poland's defences with drones and more NATO troops (in this case the RAF) being sent to Europe's Eastern flank, it is clear that the threat to our security is

not going to 'just go away' any time soon.

In another part of Defence, the Chief of Defence People, as one of the last acts of a post now disestablished, has just announced the launch of ZigZag careers, where the intent is that people can leave the service for a while, gain experience in civilian life, and return, more experienced and therefore bringing different perspectives. This goes hand in hand with enhanced Reserves. This increased flexibility of employment is designed to increase both skills (a Skills Passport was also launched at the same time) and increase retention. We can only hope it achieves its ambitions, to ensure that the military is kept up to date with developments in the civilian world and improve retention.

It is at times like this, when the future seems more uncertain than in the past, that the camaraderie and friendship of veterans seems much more relevant and important, and I think it is no coincidence that an Afghanistan Veterans charity has been launched, for the 160,000 soldiers who went through that campaign. It is also when our values and standards, that none of us forget from training, appear to be more relevant than ever, not least the concept of helping each other when in need. It is this that the Association is so good at, keeping the slightly reducing numbers always together. We have to thank Joe our Chairman, Andy

our Secretary and the whole team for that, for their unstinting work, always done with seeming ease and good will.

After 10 years of having the honour and privilege of being your Honorary President, I have decided to hand on this treasured baton to another, younger and more dynamic, to take this wonderful institution forward. I am delighted that my very good friend, Maj Gen Neil Marshall, who many of you will know, has accepted the challenge. As I look back on the last decade, I believe you should be deeply proud of what you have achieved. From representing the Association at every possible opportunity, to ensuring that those who have died are properly commemorated, to a celebratory silver Anniversary, with a magnificent silver centrepiece attached, and to the finding of new members of the association, so much has been accomplished.

As we end a year that has had more than its fair share of unpredictable events, difficult politics across the western world, and in the face of continued Russian aggression, I wish you all the very best. And as ever, I wish you all a Merry Christmas and Happy New Year.

The Kemish Award. The Kemish Award honours outstanding contributions to the Artillery Clerks' Association, commemorating the legacy of Trevor Kemish and his commitment to unity, service, and growth within the Association. It is presented annually to a member or honorary member who has demonstrated exceptional dedication and impact.

- **Eligibility & Criteria.** Open to active, paid-up or honorary members with at least five years of membership. Nominees are assessed on leadership, innovation, mentorship, welfare support, teamwork, and representational duties.
- **Nomination & Selection.** Nominations, endorsed by another member, must be submitted by 14th March each year. The Association Committee selects the recipient before the AGM, based on the quality, impact, and alignment of contributions with the Association's values.
- **Award Presentation.** The award is presented by the Honorary President at the Annual Reunion Dinner in July and publicly recognised across Association channels.
- **Governance & Review.** The process is overseen by the Association Chairman and

Secretary, with annual reviews and member feedback ensuring transparency and continuous improvement.

Nomination Forms for the Kemish Award are to reach the Association Secretary by 15th March 2026). A copy of the Nomination Form is attached to this Newsletter, available on the Artillery Clerks' Association website or on request from the Association Secretary.

I was honoured and privileged to represent The Artillery Clerks' Association at Gunner Sunday at The Royal Hospital Chelsea on Sunday 13th April 2025.

This year Richard Horner & his wife turned up. We had a most enjoyable lunch and a drink in the

bar. Also in attendance was Ted Fairbrass.

The Royal Hospital Chelsea was established over 300 years ago, during the reign of King Charles II, to provide a home for soldiers "broken by age and war." In 1682, the King commissioned Sir Christopher Wren, one of Britain's most celebrated architects, to design this sanctuary for veteran soldiers. The site chosen was in Chelsea, adjacent to the River Thames, where an earlier of Charles' projects, the huge but unfinished 'Chelsey College' stood. By 1692, the Royal Hospital opened its doors, welcoming the first 99 Chelsea Pensioners, and by the end of that year, several hundred veterans had made this their home.



Wren's design, inspired by the Hôtel des Invalides in Paris, initially featured Figure Court, which housed 412 veterans and their officers. As the need grew, Wren expanded his design to include Light Horse Court and College Court, ensuring the Royal Hospital could accommodate more residents. The Hospital's early funding came from deductions

from Army pay, which remained its main source of revenue until 1847.

Ranelagh Gardens and the Rotunda

Part of the Royal Hospital's grounds was granted to Richard Jones, 1st Earl of Ranelagh, in 1698. He transformed the area into the Ranelagh Pleasure Gardens, which became a popular venue for entertainment, and included the Rotunda, a magnificent concert hall, where a young Mozart once performed to fashionable crowds.

The Gardens closed in 1803 and the Rotunda was demolished in 1805. Following the construction

of the Embankment, the gardens were redesigned in the 1860s and still echo this vibrant past as a venue for shows and festivals.

Wartime Resilience

The Royal Hospital has endured significant challenges, particularly during the two World Wars. In the First World War, the Hospital suffered heavy damage, and during the Second World War, it was directly hit during the Blitz. The Soane Infirmary's East Wing was destroyed by an aerial mine in 1941, resulting in the loss of lives, including four nurses and eight Chelsea Pensioners. The North East Wing was also severely

damaged by a V2 rocket in 1945. Despite these incursions, the spirit of the Royal Hospital and its residents remained resolute.

Modern Era

In the post-War years, the Royal Hospital saw significant restoration and modernisation. The Chelsea Pensioner accommodation, known as 'berths', was enlarged in 1954-55 and again in 1991, to better meet the needs of its residents. The Margaret Thatcher Infirmary, a state-of-the-art care home and hospice, opened in 2009, further enhancing the level of care provided.

The Royal Hospital's historic buildings, such as the Great Hall and the Long Wards, have been meticulously restored. The Great Hall, with its impressive mural painting of Charles II on horseback, and Wren's original Figure Court remain central to the Royal Hospital's identity. Today, the Royal Hospital Chelsea continues to serve as a living monument to the nation's gratitude, providing a home, care, and community to the veterans who have served their country.

- alcohol or drug misuse
- the side-effects of medical treatment

You must make an LPA whilst you are still capable of making decisions for yourself. This is called having mental capacity. There are two types of LPA:

- property and financial affairs LPA
- health and welfare LPA

You don't have to make both types of LPA at the same time.

Property and financial affairs lasting power of attorney

A property and financial affairs LPA can give someone the authority to deal with and make decisions about things like:

- buying or selling property
- bank, building society and other financial accounts
- welfare benefits
- tax affairs
- debts

You can give someone power of attorney to deal with all your property and financial affairs or only certain things, for example, to operate a bank account, to buy and sell property or change investments. If you want to make an LPA which only deals with certain matters, you should make sure that it is drawn up very carefully so that the attorney is very clear about what authority they have to deal with your affairs.

A property and financial affairs LPA must be registered before it can be used. However, you don't have to wait until someone loses their mental capacity before using it. A property and financial affairs LPA will come into effect

as soon as it is registered. This means that the attorney will be able to start making decisions about your property and financial affairs straight away, even if you are still capable of making your own decisions. If you don't want the attorney to be able to make decisions about your affairs straight away, you should make sure that the LPA says this.

The LPA must always include authority for the attorney to make decisions once the donor has lost their mental capacity.

Health and welfare lasting power of attorney

An LPA about health and welfare can give someone authority to deal with and make decisions about things like:

- where you live
- your day-to-day care, including what you wear and what you eat
- your healthcare treatment
- what contact, if any, you should have with certain other people

You can make a health and welfare LPA which deals with all aspects of your personal welfare, or only certain things.

It's not possible to use a health and welfare LPA until the person who made it has lost their mental capacity. The LPA must be registered before it can be used.

Make a lasting power of attorney

You must make an LPA whilst you're still able to make decisions for yourself. You should choose the person who you want to look after your affairs very carefully.

Whilst the majority of our members are in good health, it is important to make plans for the future to ensure your families can manage your affairs during any period of incapacitation. The main area that this involves is the appointment of Powers of Attorney to manage your property and finance and/or your health and well-being.

Lasting Power of Attorney

If you want someone to look after your affairs for a long period of time, you can give them a lasting power of attorney (LPA). An LPA is different from an ordinary power of attorney because:

- you can make an LPA which looks after your health and care decisions and one to look after your property and financial affairs
- an LPA must be registered before it can be used
- an LPA lets you choose people to look after your affairs if you lose mental capacity

Anyone can make an LPA in case they ever lose mental capacity. This doesn't mean you're expecting it to happen, it's something you might want to do in case something happens in the future.

The kinds of illness which might prevent you from making decisions for yourself include:

- dementia
- mental health problems

The person you choose to look after your affairs is called an attorney.

There are two ways you can make an LPA. You can:

- make a lasting power of attorney on GOV.UK
- download the forms - you'll need to fill them in, then print them off and sign them

There is one form for a property and affairs LPA and a different form for a health and welfare LPA. If you want someone to look after your financial affairs and your health and welfare, you will need to make two separate LPAs and fill in both forms.

There are notes which come with the forms which tell you exactly what to do. You should read these very carefully.

Register a lasting power of attorney

Once you've filled in these forms, you will need to register the LPA with the Office of the Public Guardian. If you're the donor and you still have mental capacity, you can apply to register the LPA yourself. The person named as your attorney can also apply to register the LPA. They can do this at any time, whether you have lost

mental capacity or not.

To register the LPA, send the completed form to the Office of the Public Guardian. If you need to pay a registration fee, you'll need to send it with your completed form.

If you make both types of LPA, you will need to pay two lots of fees. Some people don't have to pay any registration fees. You can find out how much an LPA costs on GOV.UK.

If the LPA has been correctly completed and there are no objections to the registration after people have been notified, the Public Guardian must register it. It takes around 20 weeks for the Public Guardian to register the

LPA. They must notify the donor and any attorneys that they have registered the LPA.

You can use the LPA once it has been registered. You can now register the LPA with anyone who needs it - for example banks or doctors.

End a lasting power of attorney

There are a number of ways to bring an LPA to an end. These include:

- the person who made the LPA (the donor) can cancel it if they still have mental capacity.
- the attorney can say they no longer want to be an attorney - they must do this on form LPA 005 which is sent to the donor, the Office of the Public Guardian, and any other attorneys.

An LPA will also come to an end when the donor dies. A property and financial affairs LPA will come to an end if either the donor or an attorney becomes bankrupt.

You can choose to end part of an LPA. For example, you might want to remove one attorney. You need to do a 'deed of partial revocation'. You should get specialist advice to do this.

as a clerk was transferred into the military. He was promoted quite quickly and there is some suggestion that he might have been selected for officer training. He was posted around the UK and France, and in 1918 he received a posting order to move to Jamaica.

He embarked on the SS Tortuguero at Liverpool on 24th June 1918 but never made it to his new posting. His ship was sunk by U-boat U156 on the 26th June 1918. There were 12 deaths when the ship went down, 10 crew members and 2 soldiers, one of whom was Henry.

After experiencing the horrors of the western front, Henry came close to surviving the war but died

5 months before the Armistice, on the way to start an exciting new role in the Caribbean. Ubique!

Hopefully this edition of Cross Quills, focussing as it does on the history of the Association, will encourage members to write about their experiences of serving and bring to light old photos that they have stashed away in draws and boxes. Send them in and we will add them to the history of the association and all those that had the honour of bearing the title of 'Artillery Clerk'.

volunteers worked alongside experts from Heritage Malta, gaining valuable skills and making a lasting contribution to preserving Fort Delimara for future generations.

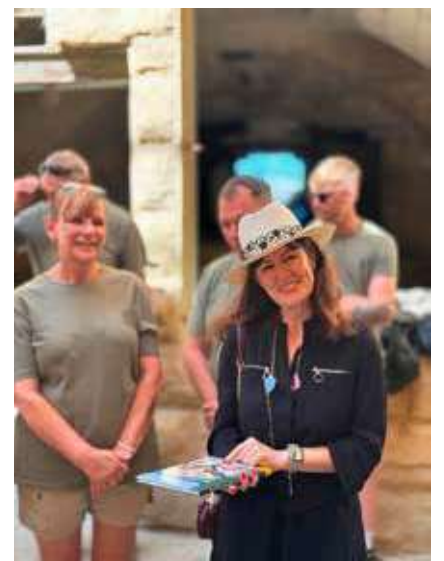
This successful international collaboration is a shining example of what can be achieved through community, charity, and shared purpose—and how acts of restoration, both physical and personal, can go hand in hand.

Royal British Legion Malta

A number of years back, during one of his visits to the island, a certain Joe Falzon paid a courtesy visit to the RBL offices in Valletta. During that visit he 'happened' to mention why wasn't Peter Gauci, (who had recently returned to live in Malta after 30 years of absence) a member of the British Legion? Sure enough I got an unsolicited telephone call from the Membership Secretary asking me if I would join the Legion – that was around 24 years ago – and that is how my journey with the RBL in Malta started. It is little consolation that I did receive a call on my mobile from Joe, 'advising' me that he might have dropped me in it! No worries I said - at that time, I was still in full time employment battling for market share against Vodafone, having joined a young fledgling telecoms company, **go mobile**, from which I had the pleasure of retiring as the Director of Mobile services some 18 years ago.

Once I retired from full time employment, I swiftly became a committee member, followed by a number of posts – special projects officer, Standard Bearer, vice chairman, till I finally took over the helm of the Branch almost 5 years ago – I now boast as having one of the best unpaid jobs on the island! It became apparent from the early days of joining the Branch was still very much operating in the dark ages and that any form of IT and the usage of digital tools and practices were completely non-existent. It felt that I had dropped back into the dark ages (not quite as bad as being a Battery Clerk in Fallingbowl with 20 Hy Regt in 1965), but strangely reminiscent of those days.

As Special Project Officer I remember trying to carry out

a reform in the way we were making monthly cheque payments on behalf of the Royal Navy Benevolent Association to around 50 x Navy recipients who were deemed as being people who 'couldn't make ends meet' When I suggested that we should be looking at making direct bank transfers to these individuals, I was shouted down – these guys do not have Bank accounts - ahh I said, so it's nothing to do with tax avoidance then, perhaps? Years later, as Vice Chairman, I convinced the then Chairman to allow me to have a go at inviting these recipients to let me have details of their bank accounts, 'as not to do so may result in delays in receiving your payments'. Sure enough – we obtained all the Bank Account details within one month of asking. The payments are now made quarterly directly from Portsmouth – the direct payment method has been running smoothly for the last 5 years or so!

Running an overseas Branch of the RBL relying solely on volunteers brings an extra dimension to the job in hand. Gone are the tools available to the Boss of warning individuals that if their performance does not improve, he or she would receive a written warning followed by dismissal. This factor alone has a very significant impact on how one 'manages' these individuals and the Branch, their backgrounds can vary somewhat - some examples being an ex-Cpl RAF photographer, MT Sgt ex RAF (married to a Maltese whilst serving on the island), who joined the Met Police Force and later formed part of the Queens security service after retiring from the RAF, ex Captain from the RAEC, ex RN cook, Wren, Military Nurse (Poppy Appeal

Organiser), Merchant Navy, and x-pat civilians (the latter category are now few and far between as Brexit has put a nail in that coffin). The minimum roles that need to be filled and maintained are Chairman, Branch Secretary, Membership Secretary, Treasurer, Welfare Officer, Poppy Appeal Organiser, Standard Bearer and Parade Marshall. The Branch has mandatory reporting obligations to the RBL UK. Audited year end Accounts have to be submitted in a timely fashion. Additionally, local annual reporting regulations to the Malta Business Registry (MBR) and the Controller of Voluntary Organisations (OCVO) places an additional administrative burden on the Branch.

I took over the helm of the Branch during Covid. The then Chairman had to step aside to help his ailing wife. The Branch Secretary's health had been deteriorating prior to Covid, with the resultant slow but inevitable 'disappearance' of the Branch. The treasurer passed away from a sudden heart attack, and the Membership secretary shared the same faith. Succession planning in the branch was unheard of. I had no option but to practically run the Branch on my own for a few months. This forced me (and allowed me) to start the necessary transformation of our practices from paper to the digital era. Over a period of some months, I located a new treasurer, membership Secretary, Branch Secretary and Standard Bearers. All these people had to 'discover' what their duties entailed as we went along. I adopted modern communication tools with the use of social media and the creation of chats groups, always keeping in the back of my mind that any undue pressure would result in sudden vacancies! We created

a new and lively webpage and FB page that are kept constantly updated with ceremonial and social events. I now send regular emails to 75% of the membership who have email addresses. The transformation is in place, but it never stops.

On my part I have established a good working relationship with the various Embassies - the British High Commission, the American Embassy, the Australian Embassy the German, Indian and Italian Embassies, The Armed Forces of Malta, the various service organisations on the island – RAFA, RNA, GCIA, BRA. Apart from the Remembrance Day service the Legion now gets invited to parade the Standard and lay wreaths at the many annual ceremonial events that take place on the island. Three years ago, we were approached to take over the organisation of the annual commemorative service of the famous Operation Pedestal (The Malta Convoy), or as its locally known the Santa Marija Konvoy. The King's Coronation gala dinner and dance gave birth to annual fund-raising events.

Hey-ho – it's a labour of love, but hugely rewarding. I have thrown all my administrative, managerial and commercial experience at it, and made it the best unpaid job on the island! The present Chairman of the Artillery Clerks' Association has a lot to answer for!!



The Falklands Revisited

Back in 1982, a L/Bdr (Stephen) Beasley and I were serving in 29 Commando Regiment when on 1st April the Argentines invaded the Falkland Islands. The Regiment was called into barracks, and we were told to be ready to leave as soon as the ships, primarily moored at Devonport were loaded. We were both on the LSL Sir Geraint and did all administration for the embarked force as well as training for war. It took six weeks to arrive in the Falklands with a stopover at Ascension Island to move stores between ships plus went ashore to zero our weapons and a route march!

We landed by helicopter some 90 minutes after sunrise on the 21st May at Wreck Point overlooking San Carlos Water. We were based at Regt Main HQ, co-located with the FDC, Cym CP, 2IC Party, RSM & Regiment Survey Officer. The main reason we were there was to man the Casualty Occurrence Cell, that worked directly to the Field Records Office as well as the normal clerical facility. Thankfully, we didn't fulfil our primary role.

Sub unit clerks took on the same role at their level. With the

shortage manpower, all clerks had other roles as well. Regimental Main HQ firstly moved from San Carlos via Teal Inlet to Estancia House, then onto Goat Ridge and finally into Stanley arriving on 15th June. The Regiment were all back in UK by the 13th July and ten days later had 6 weeks leave.

On 23rd August I flew with my family to Germany and joined 5th Heavy Regiment in Hildesheim. I lost touch with Stephen and tried a lot of avenues to find him without success.

Some 41 years later I had a communication from the Commando Association asking if I could vouch for a Beasley! We met in a Pub on Plymouth's Barbican when I was there for the 60th anniversary reunion of 95 Regiment in March 2024. Despite the 42 years between seeing each other, we (seemingly) got on extremely well and still recognised each other at first glance, subsequently using WhatsApp to remain in touch. Stephen went on a solo recce of the Falklands in May 2024 flying via Santiago in Chile and using the weekly (Saturday) commercial flight and once he was back, we started discussing plans for us to visit the Falkland Islands in 2025.

"Op Cussell" started in the February when we submitted Applications to SAMA '82 for the twice weekly concessionary RAF flights from Brize Norton.

Some 3 weeks before our 15th May departure we were notified that we had been allocated seats on the aircraft. It turned out that there were 61 passengers for an Airbus 330 Voyager aircraft that

had some 290 seats! Then our flight was delayed by 24hrs due to Rotor Winds. April/May had been a particularly bad month for Rotor Winds and several aircraft had been delayed. Our plans changed accordingly.

So, the 15th May arrived. I drove to Oxford Parkway Station to pick up Stephen to go via a pub in Witney and then proceeded to Brize Norton for the flight. After all the security checks, we were given security passes including a car parking permit and for us to move around the base unescorted. We then checked in and paid for our flight costing £268.00 return (concessionary fare for all SAMA travellers). It was then up to us to find things to do during the 4 hours after check in closed prior boarding the aircraft operated by the airline Air Tanker. In hindsight they could have used us to check the perimeter fence during that time!!

The light passenger load gave us the opportunity to be very comfortable using the middle row

of four seats where we could go horizontal. Taking off at 0055hrs, flying time to Ascension was 8 hours 15 mins, an uneventful flight with most people sleeping. On arrival we disembarked to the lounge for 2 hours, had a crew change and aircraft refuelled. The NAAFI provided free wifi.

Back on board for another 8+ hours flight to Mount Pleasant Complex (MPC) we met WO1 James Goatham (Royal Engineers) and his wife Debbie who are based at MPC. Flight landed at 1600hrs to a warm welcome by the staff on passport control. Once clear of customs we boarded our Penguin Travel transport for the one-hour journey to our home for the next 10 days which was an apartment on the Stanley waterfront. We got ourselves settled and then went to Falkland Island Company West Store to gather our supplies.... water, water that turned into wine & water that became beer!

On Saturday 17th May we had an early start, the weather wasn't too bad at all and we toured Stanley on foot visiting the Memorials. During this we were invited into a Royal Marines house (Geoff) for coffee and got a surprise briefing as to what was going on whilst we were there (more later). We then continued with the Historic Dockyard Museum, although small it was very concise about the whole of the Falkland Islands history. Including a feature of the memories of young islanders of the Falklands War. Our last task

before sunset was to collect the Toyota Hilux we had hired for the stay.

Sunday 18th and Monday the 19th we had very heavy rain and high winds. With also a low cloud base hiding the upper elevations of the mountain top we decided to stay at near sea level and thus drove to Goose Green. Being a Sunday made no difference, as outside of Stanley the only other eatery is at there. On the way we visited the Royal Engineers Memorial, to pay our respects. Mick Melia who was a Sapper Cpl in 59 Independent Commando Squadron Royal Engineers was killed during the notorious battle for Goose Green, he was also my next-door neighbour in Plymouth.

Our last call for the day was to visit Fitzroy to see the memorials for the RFAs Sir Galahad and Sir Tristram and The Welsh Guards. Monday, we visited Liberty Lodge in Stanley. I had help from John Francis (BSM 7 Cdo Bty during the conflict) who has visited the Falklands a few times. He put me in touch with Christine Ford who is the Liberty Lodge Manager. We were delighted that there were some Royal Marines from 45 Commando RM and had a good chat with them. One of them was called Mick Melia, who questioned me about Mick Melia the Sapper as it had been reported to his brother (who was also in the conflict) that he was reportedly killed at Goose Green. But it was sorted out very quickly which one had actually died. We joined them in the evening for a few drinks in the Narrows Bar. A great night swinging the lantern!



Tuesday 20th came and the weather had improved a little so we climbed up Mount Harriet

with a view to yomping to Goat Ridge behind it. On top of Mount Harriet, the weather was closing in and recorded the temperature as a chilly -16.7F on a Beasley gismo. We took the decision to come off the mountain and go to Cape Pembroke to look for penguins. They too had decided to stay away during this bout of bad weather.



That evening we were invited to The Governor's Reception in honour of Lt General Sir Charles Strickland KCB OBE RM held at Government House who was visiting the Island to attend the Landing Memorial Service. Upon arrival we were welcomed by Her Excellency, The Governor Alison Blake CMG in the Entrance Hall. We introduced ourselves and she showed us to the bar and then introduced us to other attendees from the serving military personnel from MPC, selected islanders, retired Royal Marines who settled in Stanley and (serving) Dutch Marines. A true privilege to be there and a great evening.



It was a very early start on the morning of the 21st to drive to San Carlos Settlement for the Landing Day Commemorations. The islanders had prepared hot drinks and food in a tented area to the rear of the Cemetery as a meeting place prior to holding the

service and for a light lunch after. The service was very poignant for Stephen and I as we could just make out Wreck Point House which was our landing place 43 years ago to that day. We met many of the people who were at the Governor's Reception the night before. The Governor spent time with us and after the service chatted as we walked back to the reception tent.



There were also members of 14 (Cole's Kop) Battery who are the resident Sky Sabre Battery. It was great meeting them after the service and hearing how they were getting on and enjoying being stationed at MPC. We had plans to go on to Ajax Bay but the weather was closing in, so we returned to Stanley.

Heading back towards Stanley we took several hours from our vehicle to walk to Goat Ridge, our final position on the 12th June. Cease fire was declared on 14th June. It is located to the north of Mount Harriet and to the south of Two Sisters with Mount Kent to the west of the Ridge.

The area is "littered" with the effects of 29 Commando's guns! Friday was another windy day with some showers, we had a morning meeting with Simon

Browning (who we had met at San Carlos Cemetery) for a discussion on the Artillery used during the Falkland's War. He had subsequently served at MPC and amazingly liked the Island so much he decided to settle following his military service and now provides battlefield tours to the visiting cruise ships passengers and others who want to be informed about the 74 days it took to recapture the Island. We answered his many questions and gave him the entries that had been in the 1982 Gunner magazine.

After the meeting I went shopping for gifts to take home and then we went out to Yorke Bay and Gypsy Cove looking for penguins - a failed mission.



We had an extra early start on Saturday 24th, as WO1 James Goatham had arranged for us to go on a Welfare Helicopter Trip from Mount Pleasant (MPC) to Volunteer Point. Being winter in the Falklands, it is the only method of transport to reach the area. We needed to be there at 0800hrs for briefing before the flight. Being Veterans, the flights were free, the Sikorsky S-92A was operated by Bristow Helicopter Group. For some years there has been no military helicopters operating on the Island. The RAF operate an A330 air tanker to refuel 4 Typhons. Bristow Helicopters

also provide another Sikorsky S-92A solely for search and rescue operations. It was a truly memorable day and we finally found (king) penguins in the thousands.



Sunday 25th, we visited our first landing position (by helicopter) at Wreck Point House located on Red Beach that can be seen in the distance.

From Wreck Point we yomped down to Ajax Bay to where the battle field hospital was located, known as the Red and Green Machine commanded by Surgeon Captain Rick Jolly RN who was proud that every person who was a casavac to this location amazingly survived.



Monday 26th was our last full day and due to the poor weather, we remained in the Stanley area.

Tuesday 27th we set off at 0400hrs from Stanley to MPC for the 18+ hour journey to Ascension and onto Brize Norton.

In May 1982 there were approximately 1,250 islanders that has now grown to around 3,700.

The most amazing thing was the number of Islanders and their children that thanked us for what the Task force had achieved, whilst we toured the island.

Minutes of the Virtual Annual General Meeting held on MS Teams on Tuesday 13th May 2025

1. Agenda Item 1 - Opening Remarks by the Chairman

4. Agenda Item 4 - Approval of the Minutes of the AGM held on Tuesday 14th May 2024.

4.1 The Chairman said that the Minutes of the AGM held on Tuesday 14th May 2024 had been circulated in advance via Crossed Quills (Issue 28) and that it was not intended to read them at the meeting.

4.2 ***A proposal by Ron Holmes, seconded by Richard Horner to confirm that the Minutes were a true and accurate record was CARRIED UNANIMOUSLY.***

5. Agenda Item 5 - Matters Arising from the Minutes of the AGM held on Tuesday 14th May 2024.

5.1 There were no matters arising from the Minutes of the AGM held on Tuesday 14th May 2024 which were not included in the agenda.

6. Agenda Item 6 - Chairman's Report

The Chairman noted that his report had been circulated in advance and therefore would not be reviewed in full. However, he wished to highlight one particular point and to record his sincere appreciation for the dedication and hard work consistently demonstrated by the Committee Members.

He began by thanking all members for their generous donation of £800 in support of his recent project with the charity Alabare. Thanks to this generosity, ten vulnerable veterans were currently in Malta spending ten days helping to restore a Victorian fort. The Chairman described it as a deeply meaningful project and emphasised that it was made possible by the members' support. A full report on the initiative will be shared shortly via the Association's social media platforms.

He then took the opportunity to put it on record once again that all of us owe Andy Tibble, Leo Lyall, Paul Corker, Roy Deal, Dennis Norris, Steve Read, Ron Holmes and Andrew Jones a huge amount of gratitude for all they do for the good and benefit of our Association.

He then presented two important discussion papers – both Motions proposing to amend the Charter of the Association.

6.1 Motion to Amend the Charter - GDPR. The Chairman presented his paper that was circulated with the Agenda, and which had been approved by the Association Committee.

The Discussion Paper proposes that the Data Protection measures currently set out in paragraphs 19 and 20 of the Charter are changed and replaced by revised measures under the heading of "Information Policy and Private Notice". A copy of this is attached at Annex A.

This paper was prepared with assistance from Steve Read, an expert in this field. He added that the paper sets out clearly both the reason for bringing this proposed change forward but also the effect is this proposed amendment to the Charter is approved and passed.

There were no questions or points of clarification, so the Chairman asked for the vote to be taken.

The proposed amendment that the Data Protection measures currently set out in the Charter at paragraphs 19 and 20 of the Charter are changed to introduce revised measures under a revised heading 'Information Policy and Privacy Notice was proposed by Clive Nuttall, seconded by Richard Horner, put to the vote and CARRIED UNANIMOUSLY.

6.2 Motion to Amend the Charter – Association Committee Members The Chairman presented his paper that was circulated with the Agenda and which has been approved by the Association Committee.

The Discussion Paper set out to address three key proposed amendments:

1. Association Representative on the National Executive Committee

That the elected Association Representative (currently Richard Horner) to the Royal Artillery Association National Executive Committee be formally recognised as a member of our Association Committee.

2. Participation of Honorary Members

That any Honorary Member elected to serve on the Association Committee (as in the case of Paddy Butler) be entitled to attend, speak, and vote on any resolution brought forward at an Annual General Meeting (AGM) or Extraordinary General Meeting (EGM).

The Chairman added that the paper clearly outlines both the rationale for these amendments and the implications

if they be adopted. A copy of this is attached at Annex B.

There were no questions or points of clarification, so the Chairman asked for the vote to be taken.

The proposed amendment to the Charter to correct anomalies and incorporate minor changes to the composition of the Association Committee and the voting rights of Honorary members who are elected members of the Association Committee was proposed by Ian Constantine, seconded by Mick Grenham, put to the vote and CARRIED UNANIMOUSLY.

6.3 The Kemish Award. The Chairman referred to the information circulated with the Agenda regarding the Kemish Award, which outlines the rationale behind its creation. He explained that earlier this year, the Association Committee approved the establishment of the Kemish Award to honour the extraordinary contributions of a member or honorary member to the life of the Association. - **Information Policy & Privacy Notice.** The Secretary said that as part of our ongoing commitment to safeguarding your privacy and complying with the General Data Protection Regulation (GDPR), members were informed by letter sent out with Crossed Quills, that the Committee was reviewing how personal data is collected, stored, and processed. He added that as an organisation handling personal data, the Artillery Clerks’ Association is fully committed to ensuring the privacy and security of all members’ information.

He confirmed that this review has now been completed and, as a result, the **Information Policy and Privacy Notice** was formally adopted by the Association Committee in December 2024. This document has been uploaded on our website at www.artyclerkassn.org. This policy outlines our legal obligations under GDPR and explains how we collect, use, and protect your personal data, as well as your rights regarding that data.

The Association requests personal information to support our members effectively and to keep you informed about relevant events and activities. We use your information for the following purposes:

- **Association and Regimental Events:** To update you on events, activities, and news related to the Association and regimental community.
- **Connecting with Old Friends:** To help you reconnect with former colleagues and members.
- **Welfare Support:** To help, if you require support, especially related to welfare services.

By consenting to the Association holding your personal information, you enable us to manage your membership, process subscriptions and keep you informed about Gunner events and activities. Attached to the letter circulated with Crossed Quills was a form attached at Annex B. Those members who have not already done so are strongly requested to complete this form and either return it back to the Secretary by post or by sending a good clear scanned copy by email as soon as possible to Secretary@artyclerkassn.org.

We take your privacy seriously and will never share your data with third parties without your explicit consent.

- **St Barbara’s Day Service.** St Barbara’s Day Service will be held at Larkhill in the Church of St Alban the Martyr on Sunday 7th December 2025. The Service will be followed by lunch in the Officers’ Mess. Further details will follow in due course, however, all members, especially those living close to Larkhill were encouraged to attend. The Secretary urged anyone who was considering attending to inform him as soon as possible so that he could reserve places at the Service.
- **Artillery Clerks’ Association Website.** The Secretary mentioned that the Artillery Clerks’ Association Website was constantly being kept updated by the Webmaster and that it contained a lot of useful information and links for the good and benefit of our members. He urged all members to visit the website on a regular basis as well as the Crossed Quills on Facebook. The Secretary went onto thank Leo Lyall, Webmaster for all the hard work that

he had done to ensure that we have an excellent website.

7.2 Application for Honorary Membership

In the Treasurer's absence the Secretary provided the following details:

- **Subscriptions.** Subscription is set at £15 annually and should be paid on or close to 1 January. Outstanding subscriptions total £1,470.00 as of today. There are currently 14 unpaid subscriptions for 2025. As directed, the Treasurer has issued a letter to members requesting payment of outstanding subscriptions.
- **Mandate.** All members are urged to pay by mandate. If all personnel paid subscriptions by the mandate system, then this would ease and simplify the administration burden. 9 members are yet to pay by this method.
- **Gift Aid.** This is an excellent source of income for the fund. £4,979.05 to date. Our take continues to be £3.75 for every £15 individuals contribute. For the Association to claim our Gift Aid then members must complete the declaration. The Treasurer urged the 16 members to put pen to paper. The Association has now been granted charity status with effect 9th October 2020. It is estimated that a refund of approximately £450 per annum can be expected. In 2024 this was £452.59.
- **Suspensions.** In accordance with the Association's policy on suspension, The Treasurer wrote to all members who have not paid their subscriptions for 3 years. There are currently 54 members shown as 'suspended'. There are no pending suspensions for 2025.
- **Shop.** Shop stock consists of 15 ties @ £20:00, therefore totaling £300.00. There are no cuff links and lapel pins remaining.

- **Property.** Property is divided into 2 sections. Display Boards which total £400. Silver Centre Piece £9,980.00 and the newly purchased 'Kemish Award' £360.00. These items are now accounted for within the Association's Property Book. These are shown as an asset in the amount as you can see at £400.00, £9,980.00 and £360 respectfully. Annual depreciation is set at £200 for the display boards, £90 for the Kemish Award and there is no devaluation set against the Silver Centre Piece.

- **Insurance.** The insurance for the fund is valid until 31 Mar 26. It is with the firm Towergate Wilsons. The cost this year was £305.06. This includes personal accident cover for the Chairman, Secretary, Treasurer, Reunion Secretary, Standard Bearer and Regional Secretaries.

- **Conclusion.** With available cash totaling £5,049.43 (less property) the fund is healthy and strong, which sets us up well for the coming year and beyond. The Treasurer urged all members to check to ensure their subscription is £15.00 and if not, to contact their banks to amend this prior to 2026. He thanked all members for their continued support to the fund and to himself in his role as Treasurer.

David Cussell proposed, and Steve Seymour seconded, that the 'Treasurer's Report is accepted. This proposal was put to the vote and CARRIED UNANIMOUSLY.

The Chairman thanked the Association Treasurer for his custodianship of the Association's funds and especially for his ability to extract the Gift Aid Refund from HMRC.

9. **Agenda Item 9 - Assistant/Reunion Secretary's Reports**

The Reunion Secretary presented his paper which was circulated with the Agenda to all members which he hoped you have all read in advance.

He mentioned that, as of 13th May 2025, 30 Members and 8 partners had registered to attend the Dinner. Our guests will be Maj Gen Richard Clements, Major Dickie Davies and invited guests, Helen McNamara (widow of James McNamara) accompanied by Jill Palmer. And up-to-date attendance list is available on the website.

The Reunion Secretary then recommended that a sum not to exceed £1500 is transferred from the GPF to the 2025 Reunion Fund to off-set the costs for the evening for the 2025 Reunion.

Roy Deal proposed, and Ron Holmes seconded, that the sum of not to exceed £1500 be transferred from GPF to the Reunion Fund to help off-set costs for the evening of the 2025 Reunion is accepted. This proposal was put to the vote and CARRIED UNANIMOUSLY.

The Chairman thanked Roy Deal for his careful oversight and dedication in organising the annual Reunion, noting that this will be his final year in the role. He expressed the Association's sincere appreciation for his long-standing service and the significant contribution he has made to the success of these events over the years.

10. Agenda Item 10 - Welfare Secretary's Report.

In the absence of the Welfare Secretary, Dennis Norris, the Secretary delivered the Welfare Report on his behalf. He informed those present that 16 Association members are currently being monitored by the Welfare Secretary and the Committee, many of whom are dealing with serious health issues, including cancers, heart conditions, and other debilitating illnesses. These conditions are being appropriately managed by the relevant medical services.

The Secretary encouraged all members to stay in touch with colleagues who are unwell, noting that a phone call, a chat, or even a friendly exchange on social media can make a meaningful difference to someone's well-being and help ensure they do not feel isolated.

Dennis added that he, and the Committee, are always available to offer welfare support, and that SSAFA has long been the primary support for the Armed Services. Their website is well worth a visit if members feel they need further help.

Dennis, who has recently begun volunteering with his local Citizens Advice, encouraged members to check whether they or their family members are receiving all benefits to which they may be entitled. While most members receive an Army pension that may exclude them from means-tested benefits, he highlighted that several non-means-tested benefits are available—particularly for those with ongoing medical conditions. These may include Personal Independence Payment (PIP) for individuals under pensionable age, or Attendance Allowance (AA) for those over pension age.

He added that there are several benefits checkers/calculators available on-line, including on the Gov UK site, that can be used. Additionally, help or advice in this area is always available from the Citizens Advice offices. It may also be worth having a look at the Citizens Advice open site at <https://www.citizensadvice.org.uk/> and search for Armed Forces Veterans to obtain links to advice and support particular to veterans.

11. Agenda Item 11 - Historical Secretary's Report

In the absence of the Historical Secretary, Stephen Read, the Secretary presented his report to the meeting. He noted that the initiative launched last year to collect members' reminiscences of their service as Artillery Clerks has, so far, seen limited participation. While several members expressed an interest in contributing, to date only the Association Chairman has submitted a written piece.

Before considering drawing the initiative to a close, Stephen proposed giving it a renewed push, encouraging members once again to contribute to this valuable and meaningful archive. He emphasised that members need not document their entire career—rather, they might focus on a particularly memorable, interesting, exciting, or even challenging experience from their time in service.

Contributions are welcome in any format—handwritten, typed, or word processed—and of any length. Stephen reassured members that he would edit and format submissions as needed, ensuring clarity while preserving each contributor's original intent and voice.

Stephen also welcomes any photographs or documents related to members' service as Artillery Clerks—or any other materials of historical interest—that members are willing to share for inclusion in the Association's archive. These can be sent directly to him.

The Chairman thanked Stephen Read for his report and echoed his encouragement, urging members to take the time to put pen to paper and contribute their stories whenever possible.

12. **Agenda Item 12 - Webmaster's Report**

The Webmaster, Leo Lyall mentioned to those present that over the past year, his primary focus as Webmaster has been to ensure that the Association's online presence remains current, accessible, and informative for all members. This report outlines updates made to the Association's website, the continued publication of quarterly newsletters, activity on our Facebook page, and a summary of the technical challenges encountered, most notably, the temporary disruption to our email forwarding system.

Throughout the reporting year, he has kept the website up to date with regular additions to the Notices section. Key updates included:

- Announcements related to events, reunions, and official communications from the Committee.
- Updates to the Association's Charter and contact listings.
- Publication of relevant news from the wider Gunner community and veterans' networks.

The site's core structure remains robust and user-friendly, with ongoing efforts to streamline navigation and ensure content clarity.

Routine checks and updates have been applied to maintain the performance and integrity of the website. These included:

- Security patches and platform updates to ensure continued stability and protection from online threats.
- Periodic reviews of site layout and compatibility across desktop and mobile devices.

In late 2024, a significant issue arose with the website's email forwarding system. Our provider, 123-Reg, implemented a mandatory migration to a new 2nd Generation Email Platform, which resulted in an unplanned interruption to forwarding services.

Upon discovering the issue, and after several persistent exchanges with 123-Reg directly, the forwarding functionality was reinstated successfully. Measures are now in place to monitor such disruptions more closely. Leo added that he is exploring longer-term alternatives to strengthen email reliability.

The Association's quarterly newsletters continue to play a vital role in keeping members informed of key developments, achievements, and upcoming events. Each edition was distributed via email and published on the website, ensuring both direct delivery and wider access. Newsletters Issued:

- **June 2024** – Details of the summer reunion and committee announcements.
- **September 2024** – Financial updates, membership news, and remembrance features.
- **December 2024** – Seasonal message, end-of-year highlights, and archived resources.
- **March 2025** – Notification of AGM plans and calls for member involvement.

Efforts have been made to improve readability and presentation, including a shift to a cleaner, mobile friendly format. Open rates and feedback suggest steady engagement. Leo added that he welcomes suggestions from members on content they'd like to see included in future editions.

Our official Artillery Clerks' Association Facebook page remains a lively hub for day to day updates and community interaction.

- Regular posts (approximately 3–5 per week) included event reminders, historical photos, military news, and tributes to members past and present.
- Engagement has remained strong, with steady growth in page followers and consistent interaction in the form of comments, likes, and shares.
- Top-performing posts typically include visual content—such as reunion photos or “On This Day” historical posts—and generate a high level of member interaction.

Social media continues to offer a valuable means of communication, particularly for reaching members who may not regularly check email or the main website.

In addition to the email forwarding issue mentioned earlier, a few other points are worth noting:

- **Content Timing** – Occasionally, website and newsletter updates were delayed due to the need for content approval. A more structured process is being developed to improve turnaround times.
- **Member Feedback** – Feedback from the membership regarding the digital platforms is always encouraged and welcomes. Several suggestions received during the year have already been implemented.

Planned developments for the coming year include:

- **Newsletter Improvements** – Continued refinement of the layout and the possible introduction of interactive features such as polls and embedded video clips.
- **Digital Engagement** – Broader use of social media platforms to increase visibility and attract new and returning members.

Leo thanked the Committee and membership for their ongoing support throughout the past year. It remains a privilege to serve as Webmaster for the Artillery Clerks' Association, and he looks forward to continuing to support our community through the website, newsletters, and social media.

The Chairman recorded a vote of thanks to acknowledge Leo's contribution in maintaining the high standard of our Association website and social media platforms.

13. Agenda Item 13 - Germany Secretary's Report.

The Germany Secretary, Ron Holmes, informed those present that the reunion weekend that he organised in Bielefeld last November was a great success and was enjoyed by all those members who attended. He went onto mention that it was proposed to hold the same Reunion later this year between Friday 28th to Sunday 30th November 2025 to coincide with the Christmas Markets.

The Charman thanked Ron for his report.

14. Agenda Item 14 – Member of the RAA National Executive Committee's Report.

Lt Col Richard Horner informed the AGM that he had just been inducted onto the Royal Artillery Association National Executive Committee as the Wessex, South West Region and the Artillery Clerks Representative. He explained that the Committee considers and recommends changes and updates to the various RAA rules and procedures, and that he was looking forward to attending his first RAA Annual Assembly at Blackpool.

He added that, going forward he will endeavour to update the Association Committee on any issues that might have an impact on our Association. One area the Association Committee is encouraged to look into are the provision within RAA General Administrative Instructions (GAI) that cover Trophies and Awards and possible participation in the annual Standard Bearers Competition.

The Charman thanked Richard for his report.

The Association Chairman proposes the following motion:

Title: To incorporate new changes to the Data Protection measures currently set out in paragraphs 19 and 20 of the Charter

1. **Proposed Amendment:** That the **Data Protection** measures currently set out in paragraphs 19 and 20 of the Charter are changed to introduce revised measures under a revised heading, as follows:

INFORMATION POLICY AND PRIVACY NOTICE

19. The Data Protection Act 1998 has been replaced by the General Data Protection Regulation (GDPR) and the Data Protection Act 2018, which govern how personal data is collected, stored, and processed. As an organisation that handles personal data, the Artillery Clerks' Association is committed to complying with these regulations and ensuring the privacy and security of all personal information. The Association Information Policy and Privacy Notice, revised and republished in December 2024, outlines our legal obligations under GDPR and explains how we collect, use, store, and protect your personal data. It also provides transparency on how we process your personal data, the purposes for which we use it, and your rights in relation to that data.

20. The Secretary will act as the Association's Data Protection Officer and will be responsible for ensuring that the Information Policy and Privacy Notice is up-to-date and adhered to across the Association.

2. **Reason for inclusion:** The proposed revision to the Data Protection measures is necessary to ensure that the Association remains fully compliant with the evolving landscape of data protection laws and best practices.

Since the introduction of the General Data Protection Regulation (GDPR) in 2018, the regulatory environment has continued to evolve, and it is crucial that the Association adapts its policies accordingly. Furthermore, as technology and data processing methods advance, the risks associated with personal data continue to change. The revised measures will provide enhanced clarity on data protection responsibilities, strengthen safeguards for personal information, and ensure that the Association's practices align with current legal and ethical standards. This update will help maintain the trust of members and ensure that the Association continues to uphold its commitment to data privacy and security.

3. **Effect if passed:** If the proposed amendments are accepted, the Association will be able to implement updated data protection measures that reflect the latest legal requirements. This will have a positive impact on the Association's ability to manage personal data securely and responsibly, ensuring that both legal compliance and member privacy are maintained. Additionally, the acceptance of these measures will reinforce the Association's commitment to transparency and accountability, fostering greater trust among members. With the revised measures in place, the Association will be better equipped to protect members' personal information, mitigate potential risks, and demonstrate its proactive approach to data security. Furthermore, the revised measures will help ensure the smooth operation of the Association in an increasingly data-driven world, contributing to its long-term sustainability and reputation.

4. **Main argument:** The primary reason for these proposed changes is to ensure that the Association continues to meet its legal obligations under GDPR and related data protection laws, while also adapting to the evolving data security landscape. With the increasing volume and complexity of personal data being processed, it is essential for the Association to maintain a clear, comprehensive and up-to-date approach to data protection. These changes will strengthen our data management practices, safeguard members' privacy, and enhance the Association's ability to mitigate risks associated with data breaches or non-compliance. Ultimately, the revised measures will ensure that the Association remains at the forefront of data protection standards, providing confidence and security to our members and upholding the Association's values of trust, transparency and accountability.

The Association Chairman proposes the follow motion:

Title - To correct anomalies and incorporate minor changes to the composition of the Association Committee and the voting rights of Honorary Members who are also elected members of the Association Committee.

Proposed Amendments

1. Composition of the Association Committee

Amend Paragraph 16 to include a new sub-paragraph (j):

(j) The Association Representative elected to the Royal Artillery Association (RAA) National Executive Committee.

2. Association Meetings – Annual General Meeting (AGM)

Amend Paragraph 17.a.(1) by deleting both existing sentences and replacing with:

(1) All Full Members, and Honorary Members who are elected to serve on the Association Committee, are entitled to attend, speak in discussions, and vote on any resolution. Other Honorary Members may attend as observers only.

3. Association Meetings – Extraordinary General Meeting (EGM)

Amend Paragraph 17.b.(1) by deleting both existing sentences and replacing with:

(1) All Full Members, and Honorary Members who are elected to serve on the Association Committee, are entitled to attend, speak in discussions, and vote on any resolution. Other Honorary Members may attend as observers only.

Reason for Inclusion

a. To formally recognise and endorse the role of the Association Representative elected to the RAA National Executive Committee as a de facto member of our Association Committee. This enables the individual to effectively serve as a representative, ambassador and conduit between our Association and the RAA National Executive Committee.

b. To correct the existing anomaly that currently prevents Honorary Members, who are duly elected to the Association Committee, from exercising their right to speak and vote at Association Meetings, including AGMs and EGMs.

Effect if Passed

Acceptance of these proposed amendments will clarify current ambiguities, remove unintended restrictions, and reinforce the Association's commitment to fair representation, transparency, and accountability in its governance.

Main Argument

It is both reasonable and necessary that our elected Representative to the RAA National Executive Committee—and any Honorary Members who have been formally elected to the Association Committee—are empowered with the full rights to participate in discussions and vote at Association Meetings. These changes will ensure they can perform their duties effectively and without unnecessary limitations imposed by the current Charter.

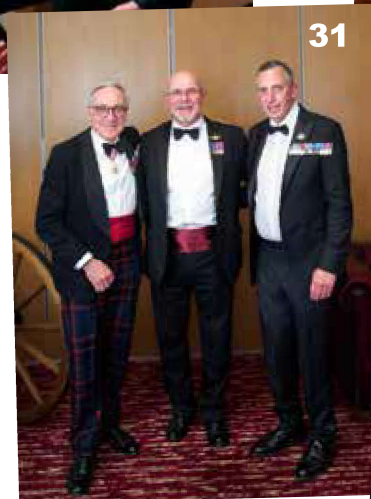

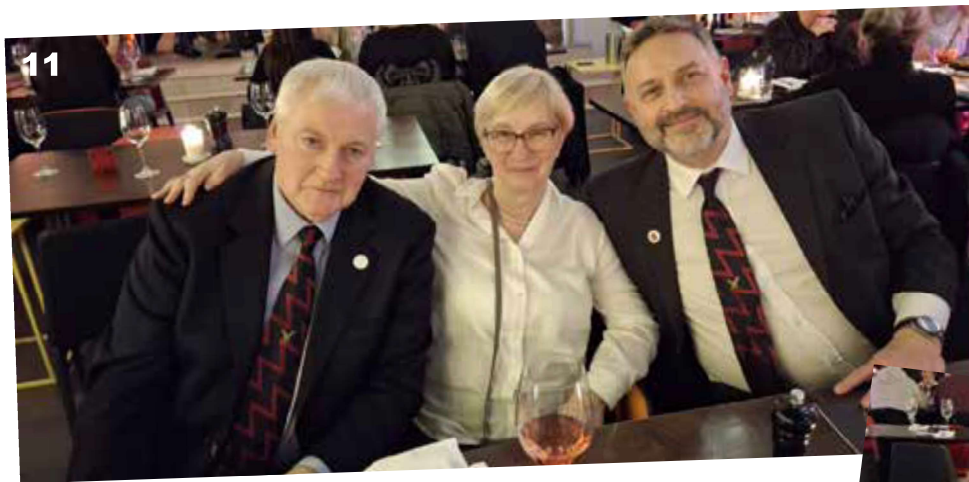

34 (Seringapatam) Battery Royal Artillery

It has been a landmark year in the history of what is now 34(Seringapatam) Battery King's Gurkha Artillery. This year saw the Battery receive the honour of becoming the first Gurkha Artillery Battery in British Army history (not withstanding a short spell in 1947). This sees the Brigade of Gurkhas expand to 7 cap badges as well as the already wide scope of trades and professions available to Gurkhas serving in the British Army.

This process began with the cap badging ceremony that took place in June, with the first tranche of new transferee Gurkha Gunners from across the Brigade alongside the Battery's Direct Entry Officers



receiving the new KGA berets in a parade attended by the newly appointed Colonel KGA Brigadier Charlie Harmer. This saw the official stepping up of the Battery as the first of many subsequent KGA Battery's. However work had already been underway to ensure the Battery and KGA HQ were fully prepared to meet the standard that the Brigade of Gurkhas would expect from a sub-unit. All elements of BHQ attended the 2 week Nepali language course hosted in Sandhurst, this is an ongoing effort and members of the Royal Regiment are continually attending the course in order to achieve a very basic grasp of the

language spoken by the Gurkhas. I was also lucky enough to attend, alongside Lt Tom Fraser, the Survival Nepali Culture and Language Course that is held for 3 months in Pokhara, Nepal. The aim of which was to allow Young Officers serving in the Brigade a chance to embrace the culture and language of Nepal in order to better understand the soldiers under their command and therefore become more effective leaders. Highlights of the course saw those attending participating in the famous 'Doko race' that forms part of the arduous selection all would be Gurkhas go through, and a Duty Trek that saw the students explore the remote areas of Nepal and work alongside the Gurkha Welfare Trust to ensure recipients of aid in those remote areas were receiving the support and care they required.



Following the cap badging the new Gurkha Gunners quickly set about learning their new trades. Initial courses were held that covered every element of a Close Support Battery, from L118 Light Gun courses to OP level 2 qualifications. This initial training cycle was followed by a deployment on Exercise Combined Warrior in August that allowed the newest members of the Royal Regiment to put their skills to the test in the austere conditions of Brecon both in Live Firing and Dry training serials. As I'm currently

writing this article level 3 courses are underway in their respective trade streams and will see some of the Gurkhas qualified as Gun 2ICs and CP acks. The training cycle will culminate in the new year with those soldiers senior enough attending their L118 and CP DC courses. The ultimate goal of this is to have a Close Support Troop with all the G4 and OP elements to support it fully trained and ready to post to E Bty 1RHA after Easter next year. This first Field Army Gurkha Artillery unit will go on to deployments and exercises around the world, sharpening and refining their new skills. Undoubtably these new Gurkha Gunners will also add impressive experience they have amassed over varied careers and as the Royal Regiment teaches them to be Gunners they will undoubtably teach us a thing or two about what it takes to be a Gurkha unit and perhaps some infantry tips and tricks at the same time.

Outside of learning their new trades members of 34 Battery have also been conducting a variety of activity, showing their abilities in a variety of arenas. the KGA entered a team into both Trailwalker a 100km race hosted by the Queen's Gurkha Signals that is a staple of the Brigade of Gurkha's calendar and EX Cambrian Patrol receiving a gold medal for their impressive efforts. Alongside sport and military activity both GURTAP and UKTAP members of the Battery immersed themselves in Nepali culture. A particular highlight was the celebration of Dashain, a Hindu festival over 15 days celebrating the victory of good over evil, this includes several key events such as the Kalarati party during which we had the honour of hosting the Master Gunner St

James's Park. A Mahanawami was also conducted, the ceremonial blessing of a Regiment's weapons, this saw a Light Gun being hand balled into the rear of the temple in order for it to be blessed in the traditional fashion.

Looking to the future the Battery will see the arrival of the newest Gurkhas fresh from Catterick at the end of November alongside the second tranche of transferees from the wider Brigade confirmed before Christmas. Another Exercise Combined Warrior sees the Battery back in Brecon before some well deserved Christmas leave. Both the British and Nepali elements of the Battery have expanded their skills and made history as the first Kings Gurkha Artillery Battery and have set the tone for the expansion of a new cap badge in both the Royal Regiment and Brigade of Gurkhas.



A Day In The Life of the Deputy Head of Membership - The Forces Pension Society
