

Foreword by the Honorary President Maj Gen Peter Currie CB



e have had three referrals this year. The first was from an 83 year old Artillery Clerk, referred by Mel Charlton, who just wanted to talk to other Artillery Clerks. He now rings about once a month and we sort the world out.

The second was a very similar case but wanted to find his medals. We managed to source a company (not MOD) that could supply for half the MOD price. This was an ex Bdr Clerk from the 1940s.

The third is ongoing and is moral support for a wife

of a current member who is in hospital with a major medical problem. We have to rely on referrals from members. Now you can see how the system works. We aim to be in touch within 24 hours and in most cases resolve them quite quickly. All cases are strictly confidential.



Notes on the Statement of Account:

General. The fund has remained financially on par with the statement last year. Assets as at 30 Sep 04 totalled £3,632:57, however the reunion fund has increased by £849:30 to £1,688:42. Total cash available to the fund however has decreased by £432:28 to £2,361:17.

Subscriptions. My main effort as Treasurer has been to reduce the level of outstanding debtors. I have written to members and the response has been disappointing, I ask all, who believe that they could have outstanding subscriptions to contact me as soon as possible. In order to give you a true feel for the amounts outstanding I have divided the totals as follows:

- a. Long-Term Debtors. Total £510:00.
- b. 2005 Subscriptions. Total £205:00.

Mandate. 48 members are not subscribing by the mandate system. Please contact the Treasurer for the forms.

Gift Aid

To date I have received £585:86 from the Taxman. So please if you are one of the 75 members, yet to complete the declaration form then get in touch with me. The fund may claim £1:41 for every £5:00 a member has subscribed to the fund. This year I have asked the taxman for £207:27. This could improve with members submitting their gift aid forms.

Shop

Roy Deal is running the shop. There are currently 33 ties in stock at a give away price of £13:00 each, totalling 429:00 in stock. The surplus of £10:25 will be transferred to the GPF.

Absence of Treasurer

Now that I'm situated in the peace and quiet of the Kent countryside I hopefully will be on call for the next two years.

Summary

This has been another year where I have failed to give my full support the committee due to military commitments however, it looks much better for 2006. The books of account are fully in date and clearly show that he fund has longterm sustainability. As Treasurer I will continue to encourage members to clear outstanding subscriptions, elect to join the mandate system and to complete the 'Gift Aid' forms ensuring income to the fund. The income is consistent with previous years and expenditure is within the parameters set by the committee. My only concern is the amount of cash tied up in outstanding subscriptions. t the time of writing this article no fewer than 16886 hits have been made on the home page and 7659 hits on the Message Board! To the best of my knowledge the site has been available to almost all users since my last report. However, I am aware that some members have had difficulties navigating around the site via the designated buttons and I will cover the top cause of this in the next paragraph. In addition I am pleased to say that the Message Board continues to be well used so a big thank you for your contributions.... well done to Paddy Corbett for his article entitled Tiger, Tiger Burning - You have been warned!

Okay one of the main reasons that some members were unable to see or activate the buttons on the site was because these buttons require JAVA Software to make them work! Following Microsoft defeat in its long standing legal battle with Sun Microsystems to have the rights to include JAVA in its operating systems Bill Gates has had to remove it! Therefore all new Microsoft Operating systems no longer ship with JAVA Software. This still left Microsoft with a headache posed by earlier releases of their software which still shipped with JAVA. This problem was sneakily overcome by the release of Windows XP service pack 2 (SP2). Once users installed this SP it automatically removed all previously installed JAVA

software. So the pesky culprit was SP2 and this is why some users found that they could no longer see or use the navigation buttons on the site.

The fix was and is simple, all you need do is re-install JAVA from the registered owners "FREE OF CHARGE". The link to the relevant website is shown below:

- Do not send too many photographs in one email as will only cause your email to take an age to be sent and for me to download it.

Ramblings of a Retired AC By Major(Retd) and former WOI(SMAC) John Reynolds

left school at the age of 15 just at the end of World War II. My education was pretty sparse, though I could read and write. I got a job as a messenger boy in the office of a company near the Temple Tube Station in London. There were three of us messengers and we were "under command" of a Royal Artillery Association Commissionaire Sgt. I don't know if any of these blokes are around any more, but during and just after the war they could be seen all over London. They wore a No 1 Dress style uniform with highly polished Gunner cap badge and buttons (no Staybrites in those days!). Our job was very menial, delivering mail etc to the various offices and running errands for the more senior members of the staff. I remember that one of my regular weekly jobs was to get the manager's tea ration from Twining's in Fleet Street. About two months before I was called up for National Service I was promoted to junior clerk in the general office. This, again, was a fairly menial job entailing the separation of invoices, mailing the original and filing the duplicate, answering the phone etc.

On reaching the age of 18 I received an invitation to serve King and Country for eighteen months. I originally wanted to do my National Service in the Navy, but they would only take me on as a three-year regular. I, therefore, opted for the Army and was influenced by our

commissionaire to select the Royal Artillery as my first choice of regiment/corps.

I reported to 68th Training Regiment RA at Birch Lines, Park Hall Camp, Oswestry, on the 7th October 1948. 68 Regt was where we were issued with our uniforms, taught the basic foot drills and put through selection tests to determine suitability for training. We had to parcel up our civilian clothes and send them back home. One other thing that we had to do at this time was to sign a form remitting 7 shillings of our 21 shillings weekly pay to our dependents. 14 Shillings a week was not very much when you had to buy blanco, brasso, boot polish etc out of it. Because I was able to assemble a bicycle pump and place a selection of different shaped pegs into the correct holes, the PSO said that I had "excellent manual dexterity". He therefore recommended me for training as an Operator Fire Control (old-fashioned name for air defence radar operator) with alternates of Driver and Clerk. What I really wanted to be was a driver.

On the 20th October 1948 I was posted to 55th Training Regt RA at Tonfanau Camp just North of Towyn in Merionethshire in North Wales. The next two months were spent learning how to operate the American SCR584 radar set and I never did really get the hang of it. After the

first two weeks of training I was appointed Squad Lbdr. This meant that I wore a vellow band on my shoulder straps and was responsible for marching the squad around and for discipline in the barrack room when the Squad Bdr wasn't around. I found that I enjoyed the foot and arms drill, but found the technical training boring. I was charged once for forgetting to open the vanes on the generator radiator and the damn thing overheated and nearly seized up! I am not sure how, but I got off without punishment. I did not manage to pass the trade test but was classified as a "Potential OFC for further training".

During training we had all filled in forms stating our wishes for postings. I applied for a posting to Hong Kong. At the end of training we were all lined up outside the barrack room

37 HAA Regt RA,

Tonfanau Camp, North Wales 1949 meant that there

dressed in Field Service Marching Order all ready to travel the world! As the Bdr worked his way down the alphabetical list there were people going off to Singapore, Hong Kong, Germany, Trieste, Egypt, Aden and other exotic places. When my name was finally called I was told that I was posted to 37th Heavy Anti-Aircraft Regt RA here at Tonfanau Camp. I was depressed to say the least. Tonfanau was not the most pleasant camp and was, in those days, pretty isolated with only two trains per day out of the place. Getting into Towyn was not very easy either as there was no direct road between the two. only a muddy track for about three miles. I picked up my kit bag and marched up the road to the RHQ of 37 HAA Regt, which was at the top end of the camp. After reporting in I was told by the Adjt that I was posted to

> 171 (The Broken Wheel) HAA Btv which was detached to Morfa Camp in Towyn. The other two batteries in the regiment were 10 (Assaye) and 111 (Dragon). This was pretty good news because it was only a 10-minute walk into town and the Bty acted as the Camp Staff for the HAA Practice Camp that was also situated at Tonfanau. This

would be access to the ATS girls who served with the TA Regts coming for their annual practice camps!

One thing that none of us enjoyed was the stupid bull that we had to endure. I never really saw the point in having to find enough pieces of wood to make a box to fit around my mattress and inside my large and small packs in order to make them perfectly square. The most stupid thing of all was having to spend our first weekend digging up turf from the cliffs by the sea and making a lawn around our barrack room, mowing it every weekend and then, immediately after the passout parade, tearing it all up and dumping it over the cliff so that the next intake could not use the same turf.

A 15cwt Tillie truck took me to Morfa Camp and dumped me outside the Bty Office. When I reported to the BSM he asked me my trade. I told him that I was a Potential OFC on the SCR 584. He told me that I was out of luck as the Bty was equipped with the British B3. Typical of the Army to post someone to a unit which did not have the equipment that he was trained on. The BSM scanned my documents and saw that I had been a clerk in civvy street. He told me that the bty office was short of a clerk and asked if I would like to change my trade to clerk. As a bty clerk I would not have to do guard duties, could wear shoes in the office and wear open neck battle dress with a tie. I was not really concerned about doing guard duties or being able to wear shoes and a tie. I also

really felt that I would like to do something different from clerking for the next 15 or 16 months. He then said that as a member of BHQ Troop I would have a room (or bunk as we then called them) of my own. Apparently Morfa Camp had been an RAF fighter base during the war and when the Bty moved in and took over, this block, which had been the NCO pilots' accommodation, was allocated to BHQ Troop. I volunteered immediately to change my trade. The necessary War office approval to change my trade was obtained and I was then sent to the RA Clerks' School in St John's Passage at Woolwich to attend Course No 44 from 26th February to 9th April 1949. Our instructor was Sgt(AC) Jim Camies and one of the other students was Gnr Les Tidy. Nine years later Les and I would be back at the Clerks' School as Ssgt(AC) Instructor's and WOI(SMAC) Jim Camies was the Senior Instructor. I lived at Kennington, which is only an hour's bus ride away, and I spent every night at home meeting up with my mates. I slept at home and returned to Woolwich each morning, usually only just in time to get on parade outside the school. I managed to pass the course, but only just, with a grading of Clerk DIII Learner.

Towards the end of 1949, a permanent staff for the HAA practice camp was established and the Bty rejoined the regiment at Tonfanau. Many of the officers and senior NCOs had served in India and much Indian was used in

the regiment. I am not sure if it was Hindi or Urdu, but we did not have lunch, we had Tiffin, weapons were issued from the Arms Kote and dhobi was issued and collected on Monday mornings - it was published like this on Part I Orders. When you heard someone shout "Hitherao, jaldi" you knew that it meant "Get here, on the double", and when the BC asked for his ghari and syce you knew he wanted his vehicle and driver. I am not sure if I have used the correct spelling for these terms.

I was promoted to paid acting Lbdr on the 1st October 1949 and then to paid acting Bdr on the 2nd March 1950 and became the battery chief clerk. I was due for demob from National Service in May 1950. One of the TSMs, WOII Ray Evans, had become the BSM. Ray was an Anglo-Indian and had done his boy's service with the Boys' Bty in India. He told me that I had good career prospects if I signed on as a regular. I had not really considered this, though I had found that I liked the responsibility and authority that the army gave me. When I was promoted to Bdr I went home on a couple of days leave to see about getting my job back when I was demobbed - by law, the firm had to give me a job. I was told that my job as a junior clerk had not been held open for me, but I could come back as a senior messenger boy. I was not impressed by this and decided that the army was the life for me after all.

I returned to Tonfanau and signed on as a regular

soldier on the 13th April 1950 for 5 years with the colours and 7 years on the reserve. I was promoted to War Substantive Bdr on the 29th August 1950. Prior to the introduction of the Peace Time Promotion Code on the 1st April 1952, there were three stages to each promotion, the first was promotion to Unpaid Acting rank then, after holding this rank for 21 days you were then promoted to Paid Acting rank and six months later you would be promoted to War Substantive rank.

Many years later I discovered a very interesting fact about Tonfanau Camp. Prior to the war, anti-aircraft live firing was carried out Watchet. Sometime before the outbreak of war in 1939, it had been decided in some part of the War Office that a new School of Anti-Aircraft Defence should be built at Tonfanau. Suitable buildings were designed and the work put in hand, but few, other than the inhabitants of Tonfanau, seem to have been aware of it. So it was with consternation that in 1942 the newly established Director of Anti-Aircraft and Coast Defence in the War Office heard that a new school of which he had never heard was ready for occupation. You can check this statement in "History of the Royal Regiment of Artillery - Between the Wars 1919 - 39", page 89.

On the 1 May 1951 I was posted to the Depot RA (Fd Wing) for drafting to Singapore for a three-year tour. I was a part of Draft DBCUF (ERE Unspecified) with no idea to what units we were to be posted

The accommodation at Woolwich was spartan to say the least. I was allocated a bed in the ground floor of one of the old barrack blocks, which had originally been the stables. The floor was a still cobblestone and mangers were still attached to the walls. For those who never knew the old Depot RA, look at the middle photograph on page 48 of "Between the Wars 1919 39". The barrack blocks still looked exactly the same right up until the last time I saw them in 1959.

After two weeks embarkation leave and a week of getting several jabs, drawing tropical kit etc, we set by train off for Southampton on the 23rd May. We boarded the SS Empire Medway, which was to be our home for the next four weeks. Our draft was allocated space in the lowest deck in the ship and below the water line. There were no portholes and no air conditioning. We were each issued with a hammock, pillow and a couple of blankets. Mess decks were several long tables bolted to the bulkhead and seated about 16 people. Getting in and out at mealtimes was quite a performance. We sat back to back with the next mess deck and you had to sit down on the bench, which was also bolted to the deck, and shuffle along sideways until all but the last two were seated. Each day two of us had to take turns to collect the meals in large dixies from the cookhouse on the main deck. By the time we had struggled down to the deck, which was especially difficult

going through the Bay of Biscay, the food was just one big all-in stew. I was lucky in that I was never seasick. I was made NCO IC Canteen Carrying Party which entailed reporting to the Purser every morning bars, canteens around the ship. Because this was a daily chore and had to be carried out before breakfast, my crew did not have to perform guard or fire piquet duties. We

and replenishing the various

were told that the Empire Medway had been an old German ship that had been commandeered as part of the war reparations - she was certainly a very old ship and not very well suited to trooping with very limited deck space. Like Pete Bunn's SS Dilwara, the Empire Medway was not stabilised and the trip through the Bay of Biscay was extremely unpleasant. After dropping us off in Singapore she continued on to Hong Kong and Japan. I later heard that the authorities considered her to be unsuitable for carrying troops, returned to the UK empty and was

consigned to the breakers yard.

We had our first shore leave in Port Said. Bumboats with their fresh fruits and tacky souvenirs surrounded the boat with lively bargaining going on and goods being passed up to the troops in wicker baskets and the money going back down the same way. Port Said was a dirty place with lots of street urchins offering us the services of their "beautiful

> sisters" who would give us a good "jig-ajig" for a very reasonable price! Needless to say, shortly after sailing from Southampton we had been given lectures, with very colourful pictures, of the dangers of contracting VD.

Sailing through the Suez Canal and the Red Sea where the temperatures were very high was extremely uncomfortable, particularly down on our troop deck at night. One night a couple of us decided that it was too unbearable on the troopdeck so we took our hammocks up on to the main deck and went to sleep up there it was only marginally cooler, but at least the air was fresher and there was a bit of air movement as the ship sailed along. At about 5 am the next morning we were rudely awakened by the ships crew soaking us with their hoses as they washed down the deck.

They were all lascars and thought that this was quite funny. When we slept on deck again we made sure that we were up early and out of the way before they washed the decks down. I must say that, once awake, I quite enjoyed this part of the day. Everything would be quiet except for the sound of the ship moving through the water. I would just sit and watch the flying fish and dolphins keeping pace with us.

Our next stop was Steamer Point in Aden where, once again, we were given shore leave. Aden was even grottier than Port Said with very little for us to see or do. Most of us headed for the Seamans Mission for a decent meal of sausage and chips and a couple of beers.

Our third and last stop for shore leave was Colombo in Ceylon (now called Sri-Lanka). There was much more here to see and do. For most of us it was the first time that we had seen many fresh tropical fruits - remember that rationing was still in force in England and even tinned fruit was considered to be a luxury. I saw my first fresh pineapple and decided to buy one. When I got back to the ship I discovered that I did not have the slightest clue as to how I should cut this thing up. Some bright spark suggested that it should just be sliced up like a watermelon. There were no other suggestions so that is what I did and shared it with a couple of my mates - it tasted delicious! The problem came next morning when we awoke to find that the corners of our mouths were very sore and

we found it difficult to talk. Apparently the juice of a fresh pineapple is a bit acidic and it burnt our mouths.

On the 19th June, halfway between Ceylon and Singapore, I celebrated my 21st birthday. We were rationed to two cans of beer per day but a couple of my mates very kindly gave me a can each so that I could celebrate in style.

We docked in Singapore on the morning of the 22nd June and the morning was spent getting our kit together and watching the hold baggage being unloaded. After lunch our draft was called forward for disembarkation and as we lined up on the dockside a WOII from Field Records appeared. He called out our names, told us which units we were to be posted to and then handed us over to a representative of the unit. When my name was called I was informed that I was posted to 1st Singapore Regt RA. I had never heard of this regiment before and had no idea what it was. I was met by none other than the Chief Clerk himself, Ssgt(AC) Nick Carter. We got into a truck and while we were driving he explained that the regiment was a Malay regiment and that there were very few British Other Ranks (BORs) in it. All the officers were British and many of the senior ranks were duplicated with Malay Other Ranks (MORs). There was a British RSM, WOI(RSM) Rex Annally, and a Malay WOI, WOI(RSM) Jamin Bin Marsom.

There were two positions in RHQ, which were ranked higher than normal. The Adjt was a major and the chief clerk was a Ssgt(AC).

The truck arrived at Jardine Steps by Keppel Harbour and we boarded a ferry that was operated by the RASC Maritime Coy based on Pulau Brani. The ferry took us to Pulau Blakang Mati, which, in those days, was just a jungle-covered island with a military barracks.

I was accommodated in a bunk on the upper floor of I Block that was just behind RHQ and completely separate from the main barrack area. There were only about 12 of us with the whole block all to ourselves. Most of the other people in the block were REME, RAPC and ACC. We also had our own kitchen with two Chinese civilian cooks. The dining room was on the lower floor of the block.

That evening I went to the NAAFI and was introduced to Tiger and Anchor beers and found that they were very tasty and rather potent! The next morning I was introduced to the tropical way of living for soldiers. I was awakened by my Sikh

mug of hot tea and two biscuits. I went for a shower and on return to my bunk I found a neatly starched olive green uniform laid out, my belt blancoed, brasses polished and boots shining. My bed was made up and floor swept. When I returned from work in the evening I just dumped my soggy uniform on the floor, went for a shower and when I came back the uniform was gone, my civvies laid out on the bed, and the bed made up ready for sleeping - all this for about half-a-crown a week. There was also the camp char-wallah who came around the barrack rooms and would serve hot tea and could produce an egg banjo in no time at all. There was also a woman, who we called Sew-Sew, who came around about once a week and would do any sewing or darning that we needed done. Our dress in 1 SRRA was olive green (OG) shirt and shorts, with hosetops, boots and puttees during the day, and trousers with long sleeved shirts at night. We also had to take a Paludrine tablet once a day to prevent malaria. Our headdress was a stiff felt jungle hat with the brim

batman, or bearer as they

were often called, with a

turned up on the left with a red and blue diamond flash and the Gunner badge superimposed, and red and blue puggaree's around the crown.

When I reported for work I found that I was the only BOR, apart from Nick Carter, in the regimental office. There were three Chinese and Malay civilian clerks and one MOR Gunner who was the Regimental Runner. My position had been added to the establishment so that there would be a BOR presence in the event of the chief clerk being ill or away on leave. All the battery clerks were MORs.

Shortly after my arrival in the regiment we were called out on IS duties in Singapore. A big trial, the Maria Hertog Trial, was causing friction between the Chinese and European members of the community, particularly the Dutch. Anyway, I was dumped off on my own at a small police station with instructions to liaise with the Singapore Police and phone in all requests for assistance to the regimental CP. I had no rations and had to eat in the police canteen. In the UK in those days, ethnic restaurants were very rare and we had not got used to eating oriental food as we are today. I lost a few pounds over those three days, which I really did not need to.

On return to Blakang Mati I got talking to Nick Carter about my future. I was quite looking forward to serving with the regiment for three years. It was a cushy posting and the island was like a small paradise. He advised me that if I stayed as a Clk GD there was virtually no possibility of promotion and if I wanted to get ahead, I should apply for appointment to the Artillery Clerks Section. If I did this, then I would most certainly be posted out of the regiment. I submitted my application and to my

surprise, I was accepted. I was appointed substantive LBdr(AC) with the war substantive rank of Bdr(AC) and on 31 August 1951 was posted to RA Branch GHQ FARELF in Tanglin Barracks in Singapore. I was to replace Bdr(AC) Bill Heaven.

The chief clerk, WOI(SMAC) Stan Spruce, told me that if I wanted promotion to Sgt(AC) I would need to get classified as a Clk BII. Thanks to WOII Ray Evans in 37 HAA Regt, I already had my ACE 3rd and 2nd Class. I duly attended a Clerk BII course at the RASC School (Far East) in Nee Soon from 5th to the 24th November 1951. During the course I had met up with a couple of Kiwi Gunners from 16 Fd Regt RNZA who were on R & R from Korea. I only just managed to pass the trade test - the final sentence in my course report read "His final paper was disappointing in view of his other work on the course, he lost marks mainly through omitting detail in many of his answers". It was rather difficult completing a trade test when suffering from a gigantic hangover from the Kiwi's farewell party the night before.

Life at GHQ was still fairly pleasant, as it was easy to get into the fleshpots of Singapore, I still had a bearer to clean my kit and the work was not onerous. The only difference was that we had to mount armed guards on the armoury and the office area. Because we were all clerks with more NCOs than privates, Bdrs/Cpls mounted as Marching Relief and LBdrs/LCpls

mounted as guards. The offices were just plywood shacks with attap roofs and raised about 2 feet off the grounds. There was no air conditioning except for wide-open windows.

Singapore in 1951 was still a very run-down city and had not changed very much since Pete Bunn's days. In fact it was probably slightly worse for wear after the war. I was lucky enough to return, as a tourist, in 1985 and was amazed at the transformation. It was a beautiful modern city with lots of wide-open spaces and lush greenery. I was even more amazed with Pulau Blakang Mati. It is now called Sentosa Island and is a huge theme park with golf courses, hotels, aquarium, etc. It was good to see that they had preserved one military part of the island at Fort Siloso.

The 1st April 1952 brought many changes to the army. The WarTime Promotion Code was cancelled and the PeaceTime Promotion Code introduced. A couple of years before, RA Records at Sidcup had produced "The Royal Artillery Shadow Promotion Roll" which placed all WO's, senior NCO's, and AC's in the order of seniority that they would have been under the peace time promotion code. In the case of the Artillery Clerks' Roll it included Lbdr(AC) to WOI(SMAC). In some cases, the individual would be placed two, and sometimes three, ranks lower than the one actually

This held implications for me. I was to revert to Lbdr(AC) on the 1st April

and would then be surplus to establishment. This meant yet another posting. This time it was to another command completely. I was posted to HQRA 40th Infantry Division in Hong Kong. I don't know how he did it, but Stan Spruce managed to get me on a RAF flight to Hong Kong. Two days flying, via the Philippines, was better than a week on another troop ship.

I will always remember one amusing incident. The Branch had submitted a transport request, whilst I was still a Bdr, to take me to RAF Changi to catch my flight which was on a Sunday afternoon. A Chinese clerk in the transport office thought Bdr was an abbreviation for Brigadier. This resulted in a staff car for me and a Landrover for my kit, turning up outside the barrack room to take me to Changi. The rest of the blokes in the barrack room were very, very impressed!

Needless to say, when I reported in at RAF Changi. I found that the flight was delayed until the next day. This meant me staying in the transit accommodation and eating in the RAF OR's dining hall. I found that they had white tablecloths on the table and the food was very good. We flew out on the Monday morning in an Andover. We had a refueling stop at Labuan in North Borneo and then flew on to the US air base at Clark Field in the Philippines for an overnight stay. When we went for breakfast the next morning I was asked by the cook how many eggs would I

like and how would I like them – I asked for three, sunny side up, and got them. Remember Britain and the army was still on food rationing. We only had one fresh egg once a week and that was for breakfast on Sunday mornings. The rest of the week we had to eat powdered eggs which, in those days, was not very palatable.

We continued our journey the next day and I cannot remember whether we stopped anywhere to refuel, or flew directly to Hong Kong. Anyway, we arrived at RAF Kai Tak late in the afternoon and, needless to say, there was no one to meet me and the RAF did not know what to do with me. They wanted to get rid of me so they dumped me off at HQ Hong Kong & Kowloon Garrison which was located in the Old Railway Hotel in Middle Road near the junction of Nathan and Chatham Roads. It was early evening and the HQ was closed but the duty clerk phoned HQRA 40 Inf Div which was located in Far East Farm Camp near Castle Peak in the New Territories. They sent the duty truck down to pick me up and I eventually arrived in my new unit quite late.

Far East Farm Camp was just that, a camp. It consisted of 4 or 5 one story brick buildings, several large Quonset huts, and tents. A barbed wire fence surrounded the camp itself. The camp was also shared with 27 (Strange's) Lt Bty RA. It was pretty primitive, even for 1952. The ablutions were corrugated iron structures with the

lavatories being just cubicles with "honey buckets" which were emptied daily by Chinese contractors.

I was billeted in a tent with three other clerks from HQRA. It wasn't too bad during the summer months as we could take the walls down to allow for free air circulation. The main problem was during the monsoon season when the torrential rain would often result in the tent floor being just a patch of mud. I found that we still had bearers (called batmen in Hong Kong), charwallahs etc. except that they were all Chinese instead of Indians. The local tailoring and cobbling contractors would also come around the tents

in evenings, measure you up for new clothes and shoes, and take payment on a weekly basis on paydays.

I reported for work the next morning and found that the Superintending Clerk was WOI(SMAC) Freddie Pask, the Chief Clerk 'G' was Ssgt(AC) Smudger Smith (I never did find our his first name), and the Chief Clerk 'AQ' was Sgt(AC) Bill James. I was to be the AQ clerk working under Bill James and we became firm friends and stayed in touch right up to his death about 8 years ago. Shortly after I arrived Bdr(AC) Brian Wolstenholme was posted in from the Training Brigade HQ at Oswestry. He was promoted to Sgt(AC) not

long after his arrival and worked under Smudger Smith in 'G'.


I found that living in a tent could on occasion be quite hazardous. I was doing some Egyptian PT on my charpoi after lunch one day when the tent suddenly collapsed on top of me. Apparently, once a year at Ching Ming, the local Chinese were allowed into military camps where there were Chinese graves in order to give them an annual clean up. One of the main guy ropes of our tent had been tied to a part of a grave right behind us and one of the Chinese men just undid it and let the whole thing collapse on top of me.

There was not much entertainment in the camp. One weekend a few of us went walking in the hills behind the camp where we found a stream. We figured that, if we could build a small dam, we would have a small pond for swimming. We "acquired" some sandbags and built the dam. This made quite a good little pond and we often went up there at weekends for a swim. One Saturday we thought that we could improve our tans by swimming and sunbathing in the nude. Whilst laying in the sun getting a good tan we suddenly heard giggling, when we looked up there was a group of Chinese girls who had been further up in the hills cutting grass for animal fodder. We never swam or sunbathed in the nude again!

During my service with HQRA 40 Inf Div I was placed on a charge on two occasions. The first time,

as a Lbdr(AC), was for allowing the driver of a 3tonner to exceed the speed limit whilst I was sitting in the cab with him. I got a Reprimand for this offence. The second time was as a Bdr(AC) when all the occupants of our tent were charged for being drunk on parade at 0800 hrs on a Monday morning. In those days we could only get beer in the NAAFI and one Sunday our Chinese batman sold us some home made rice wine. It tasted good and we woke up on Monday morning feeling good, went for breakfast and went on parade. We suddenly found ourselves staggering around and a trifle incoherent. Apparently, the tea that we had with our breakfast, had the same effect as drinking all over again. Anyway, when we explained to the OC what happened we were let off with a severe warning against the dangers of drinking home brew. It seemed that a few squaddies in Sek Kong had been drinking one of these local brews and had gone blind. After that we stuck to drinking San Miguel in the NAAFI.

Some time in December 1952, Freddie Pask told me that 14 Fd Regt were coming back to Hong Kong from Korea. They would be moving into Quarry Camp and were coming without a chief clerk. I was promoted Local Bdr(AC) and sent to join the advance party in Quarry Camp. I ran the regimental office for several weeks until a new chief clerk was posted in. When I returned to HQRA I found that I had been promoted to substantive Bdr(AC) on the 26th January 1953.

I was posted to 173 Loc Bty in Whitfield Bks 13 Apr 53 and promoted to Acting Sgt(AC) and then to substantive Sgt(AC) on the27th April 53. Whitfield Bks was situated on Nathan Road right in the heart of Kowloon and was a huge change from Far East Farm Camp. It was a purpose built barracks and we shared it with 34 LAA Regt and a Gurkha Tpt Coy. The bty shared officers and sergeants messes with 34 LAA Regt. When I returned to Hong Kong in 1985 as a tourist I found that the barracks had been demolished and turned into a very nice park.

Life in Kowloon was much more interesting than in the New Territories. There were shops, restaurants, cinemas etc. One Saturday afternoon I went to the cinema to see the movie "The Cruel Sea". Whilst standing in line to buy my ticket I saw a beautiful Chinese girl a few places ahead of me. She was with a girl friend and I thought that she was the sort of girl that I would like to get to know much better. I also knew that it would not be easy, as most respectable Chinese girls did not usually make friends with British soldiers. There was a small café attached to the cinema and, after the show, I went there to get a cold drink and who should be there but the girl and her friend. I thought "Nothing ventured, nothing gained" so I went to their table and spoke to them. The friend was the most talkative and I found that her name was Suzy and the other girl was Edna Lee. Somehow or other, I managed to get Edna to agree to a date. We found

that we got on well and we then dated on a regular basis. I knew that I was due to be posted back to the UK in May of 1954 and that this was the girl that I wanted to spend the rest of my life with so I asked her to marry me - she laughed at me! Anyway, after she realised that I was serious, she said yes. The next problem was that her parents lived in Boston, Massachusetts. Her paternal Grandmother, with whom she was living, was the de-facto head of the family in Hong Kong said it would be OK except that Edna would wait for me and if I returned within one year of my return to the UK, then we could get married - but that is another story.

My next step was to apply for a second tour, which I knew, would be difficult to get, but I had no choice but to try. I submitted my application to the BC, Major GC Willis, MC, RA, who immediately asked the reason for this request. When I told him that I intended to marry a Chinese girl he advised me, in all seriousness, that if I married a Chinese girl I could consider my military career over and that I should reconsider my intentions. It was a good thing that I ignored his advice. Anyway, he did support my application and submitted it to RA Records in Sidcup, though this was no guarantee that

I would get my second tour. I sometimes wished that I could have met Maj Willis again before I retired to let him see how wrong he had been.

I embarked on the HMT Dunera on the 3rd May 54 for my return to the UK. We had the usual shore leaves in Singapore, Colombo, Aden and Port Said.

I am not sure, but I think that I must have set some sort of record having served in four different units in two different countries and gone from Bdr down to Lbdr and back up to Sgt all within the space of three years. It was hectic but great fun and I would do it all again. To be continued.

f any proof is needed that I read 'The Crossed Quills@ throughout, then this is it! I read something like: "How about an article on your trip to Gibraltar?"

Artillery Clerks' Association Charter

General

- 1. The Association, entitled the "Artillery Clerks' Association" was formed at Woolwich on Saturday 7th March 1998. This Charter is being adopted to guide its activities. The Charter may be changed at any time by the Committee to reflect the wishes of the Association members.
- 2. The Aim and Object of the Artillery Clerks' Association is to promote comradeship amongst its members, both serving and retired and to provide a focal point for all members of the Association. The Association is essentially an old comrades association of former Artillery Clerks, either serving or retired.
- 3. The Artillery Clerks' Association is affiliated to and is a Branch of the Royal Artillery Association (RAA). All members of the Royal Artillery Association will be granted life membership of the RAA on acceptance.

Eligibility

- 4. Full Members. Full membership of the Association is open to any former Artillery Clerk in the rank range from Sergeant to Warrant Officer Class 1, either serving or retired. Membership may also be granted, with the recommendation of a former Artillery Clerk or member of the Association, to clerks who served in the Royal Artillery in the rank range from Gunner Bombardier, and have subsequently been promoted Sergeant in the Adjutant General's Corps.
- Honorary Membership.

 Honorary Membership of
 the Association is specially
 the gred to cover the widows
 and relatives of deceased

- Artillery Clerks. Other special cases of honorary membership will be considered on merit by the Committee and voted upon by the Committee and voted upon by the members at the Annual General Meeting (AGM). Honorary members may not vote on matters voted upon at the AGM.
- 6. Authorization. Membership of the Association may be sought by anyone under these rules. In the event of there being some doubt regarding application, the Artillery Clerks' Association Committee will arbitrate. The Association Committee has the right to refuse any application for membership, or cancel any existing membership, for example, for disciplinary reasons.

Purpose

- 7. The specific purpose of the Association is to provide:
- a. A focal point for comradeship, largely through periodic reunion of:
- (1) A formal Annual Reunion
- (2) An informal Dinner to be held at a frequency and location to be decided by the Committee, to include wives, girlfriends and widows.
- (3) A very limited welfare service. This essentially means that the Artillery Clerks' Association, in promoting contacts between members, provides a network through which help can be given to any member. The focus for this activity within the Association is the Secretary.

Organisation

8. The affairs of the Artillery Clerks' Association will be overseen by the Artillery Clerks' Association Committee. The Committee will meet at intervals decided upon by the Chairman, and will comprise of:

- a. President (Honorary).
- b. Chairman.
- c. Secretary. Responsibilities cover:
- (1) Association Membership.
- (2) Correspondence.
- (3) Providing a focus for the Association's welfare work and links to the RAA.
- (4) Production of a periodic newsletter.
- (5) Coordinating the activities of the Area Representatives.
- d. Treasurer. Responsibilities cover:
- (1) Maintenance of a bank account entitled the "Artillery Clerks' Association".
- (2) Accounting for all the finances of the Artillery Clerks' Association.
- (3) Presenting a Statement of Account to the Committee (as and when required) and annually at the AGM
- d. Regional Representatives. Responsibilities cover:
- (1) The recruitment of new members.
- (2) Maintaining an area membership list.
- (3) Coordinating travel to Reunions and other Association activities Areas covered are:
- (1) Northern Ireland.
- (2) Scotland.
- (3) Wales.
- (4) The North West consisting of Cumbria, Lancashire, Merseyside, Greater Manchester and Cheshire.
- (5) The North consisting of Northumberland, Tyne and Wear, Durham, Cleveland,

- North, West and South Yorkshire and Humberside.
- (6) The Midlands consisting of Derbyshire, Nottinghamshire, Lincolnshire, Shropshire, Staffordshire, West Midlands, Leicestershire, Hereford and Worcestershire, Warwickshire and Northamptonshire.
- (7) The East consisting of Buckinghamshire, Bedfordshire, Essex, Hertfordshire, Cambridgeshire, Norfolk and Suffolk.
- (8) London Area
- (9) The South consisting of Oxfordshire, Berkshire, Hampshire, Isle of Wight, Surrey, West Sussex, East Sussex and Kent.
- (10) The West consisting of Cornwall, Devon, Somerset, Dorset, Gloucestershire, Avon and Wiltshire.
- (11) Germany.
- (12) The Rest of the World covered by the Secretary.
- 9. Additional members of the Committee may be appointed by the Chairman as required, for example, Reunion Secretary and Assistant Secretary.

Fees

- 10. Membership fees are to be determined by the Committee. There is to be a fee to join the Association and the annual renewal fee.
- 11. Fees are to cover the costs of administration, including telephone calls, postage and stationery.
- 12. Reunions are to be self-financing, that is, those attending are to meet the full cost of all activities of the Reunion.






